**Bobbe Shire** has been coaching for over 45 years and is one of the most respected spin specialists in the world. She has worked with numerous national, world, and Olympic competitors, including Michael Weiss, Kimmie Meisner, Patrick Chan, Sarah and Emily Hughes, and Johnny Weir to perfect their spinning technique. She holds PSA Master Ratings in both figures and freestyle and has presented at numerous USFS and PSA conferences and training camps throughout the country.

By specializing in spins, Bobbe has developed novel teaching methods that help her students understand and execute proper spinning techniques. As a specialist, she encourages her students to “push the envelope” in terms of creativity, technical ability, and skill development.

**Additional Coaching Staff:** **Maude White**, Spin Specialist - has coached for over 45 years, is a USFS triple Gold Medalist in Figures, Freestyle, and Dance, and has competed in Eastern Sectionals at the Intermediate, Novice, Junior, and Senior Levels; **Angie Hale**, Yoga & Pilates Instructor - is an occupational therapist and registered yoga teacher in private practice, has 20 years of experience serving children and families in school based, clinical, and mental health settings using a holistic approach, and is a current skater and coach; **Dawn Harwood**, Choreographer - is a Gold Medalist in Figures and Freestyle, has competed at Scottish and British Nationals, skated for 9 years in international ice shows including Disney on Ice in the U.S. and Europe, and coaches the James River Ice Theatre among other coaching roles; **Tiffany Thornton**, Visioning Facilitator - has more than 10 years of coaching experience at the South Atlantic Qualifying Regional, Sectional, and National Levels, coaches national award winning Virginia Ice Box Ensemble (VIBE) theatre on ice team, and grew up competing at the Qualifying Regional Level.

**Mandatory Off-Ice Session:** 8:00-8:45 a.m. - This session is required by Bobbe for all skaters in order to take the clinic.

**Simultaneous On- & Off-Ice Sessions by Skill Level:** 8:45 a.m.-4:30 p.m.

**Skill Level Pre-Requisite:** Skaters must be in FS Level 3 or higher, and must be able to do a one-foot spin from backward crossovers. Skaters will be divided into four groups based upon current spin ability. One of these groups will be an adult group depending upon interest and registration levels.
